The Center for Student Legal Services (CSLS) advises and represents over 1,000 Ohio University students every year. CSLS sees students for civil matters related to what to look for when seeking off-campus housing, tenant/co-tenant/sub-lessee/landlord rights and responsibilities, non-housing contract reviews, and consumer disputes, as well as for criminal charges related to underage possession/consumption of alcohol, possession of marijuana/paraphernalia, disorderly conduct, traffic citations, petty theft and criminal trespassing. CSLS cannot advise or represent a student against another student, or provide representation in university matters (e.g. Community Standards hearings).

If a student waived the \$15 Student Legal Services (SLS) Fee from their tuition, but now wishes to be protected by our program, they may complete this form and pay the \$15 SLS fee directly to our office to re-enroll. Please be advised that re-enrollment will not be complete until both this form and the payment have been received by the CSLS staff.

6. Operating a Vehicle Impaired - \$125 (+\$25 if breath test completed)

Second+ Offense

1. Minor Misdemeanor - \$50
2. Misdemeanor 4th Degree - \$50
3. Misdemeanor 3rd Degree - \$75
4. Misdemeanor 2nd Degree - \$100
5. Misdemeanor 1st Degree - \$125
6. Operating a Vehicle Impaired - \$150 (+\$25 if breath test completed)
